Dear Village of Waldo Residents,

We are trying something new this year. We are including applications for dog licenses, burn permits and basic building permits along with the newsletters. Perhaps this will ease the process for you. Checks should be made out to the Village of Waldo. The clerk contact for questions or confirmation of charges is: clerk@villageofwaldo.com 920-528-8121. A few notes to help:

- Dog Licenses are \$5.00 for a spayed /neutered dog. \$12.00 for non-spayed/non-neutered dog. This is not a money maker for the Village; contrary to some comments the office receives. It is a State mandated requirement for us to implement. The driving force behind the licensing is the effort to protect the community by keeping dog rabies vaccinations current. Hence the need for proof of rabies vaccinations. Licenses are already available for purchase for 2021. They must be purchased by March 31st or there is a late penalty or police fine.
- <u>Burn permits</u> If you have a fire pit or burn a pile of permissible materials, you need a permit. It is \$10 and good for a year from date of purchase.

<u>Building permits</u> Questions to help you know if you need a building permit:

(These are common questions, and they all require a permit if you answer "yes".)

- Will your project increase the value of your home by \$2000? (Even if materials & labor are free)
- o Will your project change the footprint of your home or structure?
- o Are you changing wiring?
- o Are you installing a new roof?
- o Are you installing a new air conditioner or furnace?
- o Are you moving or installing a sink, toilet, shower, dishwasher?
- o Are you building a fence?
