TAX COLLECTIONS-2021

<u>Personal Property Tax</u>: Paid in full by January 31st of each year.

Real Estate Tax:

First Installment due by January 31st: Payable to the Village of Waldo

Also remember all voters need a photo Id to vote.



Utility Accounts: The Village will be upgrading to a new Utility Software. Starting February 1st, meters will be read and billed monthly. February's billing will still look a bit different because it will have January and February's meter reading on the bill.

A few reminders:

- If you've received a letter from the Village asking for you to call and make an appointment to have your meter changed, please do so at your earliest convenience. Having all meters changed to radio read will substantially cut down the reading time.
- Starting in February all residents who have a deduct meter will be responsible for calling in, emailing, or uploading to the website their deduct meter read.
- Also in February, residents will have the option to have their utility bills emailed monthly. There will be a sign up for residents wanting that service.
- Utility payment options: residents are welcome to continue paying via cash or check as before. However, there are a few new options for payment. The Village offers credit card payments through Allpaid. If you would like more information, please contact the Village office. Once the Village switches over to the new utility software, residents will have the option for direct payment. How direct payment works is that you still receive a bill showing the total due, but instead of sending in payment, the payment is taken directly from your checking/savings account on the due date. There is an authorization form to fill out.
- Accounts not paid in full by October 1st, will be sent a letter. If payment is not received by November 1st a 10% penalty is added. If by November 15th payment hasn't been received, the total amount will be sent to the tax roll.
- The Village offers a deferred payment agreement, if you are having trouble paying the full amount due. Please contact the clerk for more information.



VILLAGE REMINDERS:

- Winter Parking Restrictions are in effect until April 1st, 2022.
 There is no parking on the streets from 2:00 a.m.-6:00 a.m.
- Dog Licenses are required in the Village of Waldo. All dogs that are 5 months of age or older are required by WI State Statute to be licensed. Proof of current rabies vaccine is required. License cost \$5.00 for spayed/neutered and \$12.00 for non-spayed/neutered. Failure to obtain a license by March 31st will result in a late fee of \$15.00 per animal.
- Burn permits are required in the Village. They are valid for a year from purchase date and cost \$10.00.
- Snow needs to be shoveled from sidewalks within 24 hours of snowfall.
- Snow is prohibited from being placed in the road. Also, snow should not be piled at or near intersections to obstruct the view of pedestrians or operators of motor vehicles.
