NOTICE IS HEREBY GIVEN that pursuant to Sec. 70.45 of Wis. Statutes, the Village of Waldo assessment roll for the year 2022 will be open for examination starting on the 25th of April 2022. Examination of the roll can be done at the Village Hall, located at 810 W 2nd St, Waldo, WI, during normal business hours. Open book will be held on May 11th from 9 a.m.-11:00 a.m. via phone or email only due to COVID-19. Call or email the assessor any time before the end of the Open Book. NOTICE IS HEREBY GIVEN that pursuant to Wis Statute 70.47(1), the Board of Review will meet on Thursday June 2, 2022, at the Village of Waldo for the purpose of calling the Board of Review into session during the forty-five-day period beginning on the 4th Monday of April. The meeting will begin at 5:00 p.m. until 7:00 p.m.

*No person shall be allowed to appear before the board of review, to testify to the board by telephone, or to contest the amount of any assessment of real or personal property if the person has refused a reasonable written request by certified mail of the assessor to enter onto property to conduct an exterior view such property being assessed.

*After the first meeting of the board of review and before the board's final adjournment, no person who is scheduled to appear before the board of review may contact or provide information to a member of the board about that person's objection except at a session of the board.

*No person may appear before the board of review, testify to the board by telephone or contest the amount of any assessment unless, at least 48 hours before the first meeting of the board or at least 48 hours before the objection is heard if the objection is allowed under sec. 70.47(3)(a), that person provides to the clerk of the board of review notice as to whether the person will as for removal under sec. 70.47(6m)(a) and if so which member will be removed and the person's reasonable estimate of the length that the hearing will take.

* When appearing before the board, the person shall specify, in writing, the person's estimate of the value of the land and the improvements that are the subject of the person's objection and specify the information that the person used to arrive at that estimate.

*No person may appear before the board of review, testify to the board by telephone or object to a valuation; if that valuation was made by the assessor or the objector using the income method; unless the person supplies to the assessor all of the information about income and expenses, as specified in the manual under 73.03(2a), that the assessor requests. The municipality or county shall provide by ordinance for the confidentiality of information about income and expenses that is provided to the assessor under this paragraph and shall provide exceptions for persons using the information in the discharge of duties imposed by law or of the duties of their office or by order of a court. The information that is provided under this paragraph, unless a court determines that it is inaccurate, is not subject to the right of inspection and copying under s. 19.35(1).
