

2025 WALDO VILLAGE AND UTILITY NEWSLETTER

2024 TAX COLLECTIONS

1st Installment or full payment due by January 31st- paid to the Village of Waldo, at the clerk's office. Receipts are not automatically sent. If you are not paying in person and would like a receipt, please include a self-addressed stamped envelope.

2nd Installment due by July 31st-paid directly to the Sheboygan County Treasurer. 508 New York Avenue, Sheboygan, WI 53081-4126.

BURN PERMITS

Burn Permits are required by Waldo Code Chapter 146-10.5. The permit is good for 1-year from purchase and is issued in the clerk's office.

DOG LICENSING

All Village of Waldo residents owning a dog that is six months of age or older are required by Village Ordinance to purchase a pet license. A late penalty will be imposed for renewal pet license processing after March 31, 2025.

Fees: Spayed/Neutered \$7
Not spayed/neutered \$14
Late penalty after March 31st \$15

BUILDING PERMITS

Permit and Inspection are required for:

- New construction and dwellings and commercial buildings.
- Alterations, additions, or structural changes exceeding \$2,000 in market value.
- Electrical, HVAC, and plumbing work for new construction or remodeling.

Permit without inspection is required for: projects such as re-siding, roofing, and window replacement (with no structural change) exceeding \$2,000 in market value.

Fees are doubled if the project is started without a permit. When in doubt contact the Village's Building Inspector, Brian Witkowski at 920-912-0832.

Note: Registration is required for new residents, name changes, and address changes. Proof of residence is required when registering. If you would like to register in advance, request an absentee ballot, see what is on your ballot, or check where you vote; go to: myvote.wi.gov.

Items not allowed at curb pickup:

- **Metal:** of any kind (scrap metal can be taken to drop off location, free of charge.)
- **Electronic Waste:** Electronics can be taken to the drop off location for a fee.
- **Organic Waste:** Excessive food waste, animal carcasses, pumpkins, and other organic waste can be brought to the compost pile at the Waldo drop off location, free of charge>
- **Liquid Paint:** Dry water-based paint is accepted.
- **Drain Oil:** Oil and other petroleum products can be taken to drop off location for a fee.
- **Tires:** are not accepted at either drop off location. Contact a local mechanic to dispose of them.
- **Construction/Remodeling waste:** Dumpster can be rented, fees apply.
- **Bulky Items:** Furniture, exercise equipment, artificial trees, appliances, grills, mattresses, box springs, vacuums, etc. Can be dropped off at the Waldo location. Fees do apply.

Reminder: Recycling cannot be placed in plastic bags.

Water/Sewer Utility Billing:

- Would you like to receive your utility bill sooner and not wait for snail mail? You can sign up for e-billing and receive your utility bill via email! Contact the clerk's office at 920-528-8121 or email: clerk@villageofwaldo.com.
- Accounts not paid in full by October 1st will be sent a letter. If payment is not received by November 1st a 10% penalty is added. If by November 15th payment has not been received, the total amount will be sent to the tax roll.
- The Village offers a deferred payment agreement, if you are having trouble paying the full amount due. Please contact the clerk for more information.
- Online payments are accepted through AllPaid @ www.allpaid.com. Credit card & ACH payments will be assessed a service fee of 2.95% of the total payment.
