ORDINANCE NO. 2025-03

AN ORDINANCE AMENDING § 158-5 OF THE MUNICIPAL CODE TO INCLUDE A NO PARKING ZONE ON THE EAST SIDE OF DEPOT STREET FROM THE CORNER OF DEPOT AND SECOND STREETS WHERE SIGNAGE IS PRESENT AND REMOVING § 158-4. STIPULATION OF GUILT

WHEREAS, the Village Board of the Village of Waldo has determined the need to establish a "No Parking" zone on the east side of Depot Street from the corner of Depot and Second Streets, where two "No Parking" signs currently exist; and

WHEREAS, this restriction is necessary to improve safety, traffic flow, and accessibility in this area; and

WHEREAS, the Village Board also finds it appropriate to remove § 158-4, "Stipulation of Guilt," from the Municipal Code, as it is no longer in alignment with current enforcement practices and procedures; and

WHEREAS, the Village Board desires to update the Municipal Code to reflect these changes.

The Village Board of the Village of Waldo hereby ordains as follows:

Section 1. Amendment to § 158-5. Parking Prohibited at All Times

§ 158-5. Parking prohibited at all times. [Added 11-17-1981 by Ord. No. 2-1981]

Parking is prohibited at all times on the following streets or parts of streets:

A. Block 3 of the original plat commencing at the southwest corner of said block a distance of 20 feet east along the north side of West First Street and a distance of 14 feet along the east side of North Harmon Street.

B. Depot Street. Block 2 of the original plat, commencing at a point 23 feet south of the northwest corner, thence south 25 feet, except that official United States Mail vehicles are authorized the use of this parking area for the delivery and loading of the mail. C. The east side of Depot Street, from the corner of Depot Street and Second Street, extending to the location of two "No Parking" signs, where parking is prohibited between the signs.

Section 2. Removal of § 158-4. Stipulation of Guilt

§ 158-4. Stipulation of Guilt. [Removed 1-30-2025 by Ord. No. [Insert Number]]

The County Sheriff or an officer designated by him, upon request of any person charged with a violation of any provision of this article, within 48 hours after issuance of a citation therefor, may

~~accept a written stipulation of guilt and the required penalty from such person. Such stipulation shall be in the form prescribed by the Village Board.~~

Section 3. Penalty. Any person who shall violate the provisions of this section shall, upon conviction thereof, be subject to a penalty and shall, upon conviction thereof, forfeit not less than \$20 nor more than \$100 together with costs of prosecution and, in default of payment of such forfeiture and costs of prosecution, shall be imprisoned in the county jail until such forfeiture and costs are paid, but not exceeding 10 days.

Section 3. Effective Date. This ordinance shall take effect immediately upon passage and publication as provided by law.
