3. Certification of Compliance with Open Meeting Law:

13. Ordinance 2025-15: Adopting the Village of Waldo Public Works Construction Standards and Adding Them to the Village Code Appendix as PW-1:

Clerk/Treasurer Gillette explained to the board that the Public Works Construction Standards were approved in 2001. They were updated in 2005 and approved to be added to the code. Unfortunately, that was not followed through. Trustee Hintz motioned to approve Ordinance 2025-15. Trustee Hammarlund seconded the motion. The motion carried.

14. Resolution 2025-14: Adopting the 2026 Budget and Establishing the Necessary Tax Levy for the Village of Waldo:

President Thomas motioned to approve Resolution 2025-14. Trustee Behr seconded the motion. The motion carried.

15. Sidewalk on Third Street:

Trustee Hammarlund motioned to allow the resident to remove the remaining sidewalk on their property on Third Street. Trustee Reinemann seconded the motion. The motion carried.

16. Walkway in Berry Subdivision to Village Park:

The board discussed ideas on informing the residents about the easement in the Berry Subdivision to the Village Park. Clerk/Treasurer Gillette will send out a map to the subdivision residents.

17. Possible Land Options for Waldo Fire Department:

Trustee Reinemann motioned to give the Waldo Fire Department the first right of refusal for land of their choosing for a new fire department building. Trustee Behr seconded the motion. The motion carried.
